## Diane Skiba Profiling an Honorary Member: Kathryn Hannah

Kathryn J. Hannah, C.M., Ph.D., D.Sc. (h.c.), FACMI

Dr. Hannah is a pioneer whose involvement with computers in nursing started in 1974. As an academic, she spearheaded efforts to use computer-assisted instruction and evolved to provide consultation based on her numerous years of experience to academia, health care delivery systems, organizations, health and nursing systems. Dr. Hannah states that “as the nursing informatics field evolved, so too did her focus – from computers, to software, to data and data standards”.

She is known for her extensive expertise in knowledge transfer and change management facilitation, for which she is respected internationally. She is a prolific author of articles on computers in health care and nursing, as well as health care informatics, and also textbooks.

She was the first nurse informaticist in Canada and was their representative to Working Group 8: Nursing informatics. As one of the founding representatives of this working group, she served as first Vice Chair, then as the Second Chair of Working 8 Group (1987-1989). She chaired the first nursing session held at Medinfo 1980 in Tokyo and was also involved in the 1982 Working Group Conference and Post Conference in London. She also chaired the Second International Conference of Nursing, ‘Use of Computers and Information Science: Building bridges to the future’ in Calgary, Canada (1985). She is also one of our earliest Honorary Members.

Dr Hannah’s stellar career has been recognized by various honors and awards. Here are just a few examples: elected Fellow in the American College of Medical Informatics (1989); founding Fellow of the IMIA’s International Academy of Health Sciences Informatics (2017); awarded Maestro Illustre (1993) by the Faculty of Medicine and Health Science at the University of Guadalajara, Mexico; member of the Order of Canada for her pioneering informatics work (2015); awarded a Doctor of Science honoris causa by Athabasca University; Centennial Award from The Canadian Nurses Association (2008) in recognition of her pioneering leadership in promoting the involvement of nurses in the development and use of information systems in health care and the Canadian Health Informatics Award for Leadership (2015) jointly presented by Canada’s Health Informatics Association and the Information Technology Association of Canada. In her honor, friends and colleagues established the Dr. Kathryn J Hannah Scholarship that is administered by The Canadian Nurses
