Honorary Member: Michelle Honey

Michelle has been active in nursing informatics in New Zealand since 1991, with the original Nursing Informatics New Zealand (NINZ) organization, taking various leadership roles across the years. This was recognized by her being awarded Honorary Member status of the new merged organization, Health Informatics New Zealand (HiNZ), in 2001. In 2002 she also received Fellowship status with the College of Nursing Aotearoa New Zealand for her nursing informatics activities.

In addition, Michelle chaired NI2000 when New Zealand hosted the International Nursing Informatics Congress, and in 2004 she received Honorary Member status of the International Medical Informatics Association Nursing Informatics group (IMIA NI). Internationally, for IMIA-NI, Michelle has attended many of the congresses and supported IMIA-NI through being an active member, reviewing, being a session chair and judge for student submissions. Michelle has served on the IMIA-NI Education Working Group since 2003, first as New Zealand country representative (2003-2006), then as Chair and Co-chair until 2017 when Michelle took up the position of New Zealand representative to IMIA-NI. Michelle was Chair of the Editorial Committee for NI2021 and also on the Scientific Programme Committee, and currently Michelle is Vice Chair for communication on the IMIA-NI Executive Board.



Nationally, Michelle has been recognised and in 2010 was the inaugural recipient of the Robyn Carr Spirit Cup for steadfast commitment to furthering the goals and achievements of nursing informatics in New Zealand, and in 2021 became a Founding Fellow of Health Informatics New Zealand (FHiNZ) awarded in recognition of Health Informatics leaders who demonstrate significant digital and data achievement and contributions, leadership and service for their health and disability sector. Internationally, in 2022 Michelle was elected as a Fellow of the International Academy of Health Sciences Informatics (FIAHSI).

Michelle supports the continued development of nursing and midwifery health informatics in New Zealand. She currently works at the University of Auckland in the School of Nursing where she continues her research, publications and support of nursing students. She is a prolific author and a mentor for many students in the field of informatics.

Memorial for Dr. Virginia K. Saba - August 8th at Arlington National Cemetery

Dr. Virginia K. Saba's funeral service will be held on Tuesday, August 8th at 12:45pm at Arlington National Cemetery. Her niece shares the following information: People must arrive at the Old Post Chapel at Fort Myer 45 minutes early, at noon. Everyone is welcome. You must arrive in a car. There will be a Catholic service followed by a procession, using our cars, to the Columbarium at Arlington Cemetery where she will receive full military honors by the U.S. Coast Guard.

The reception afterwards, to which everyone is invited, will be at the Army Navy Country Club nearby.
