EFMI projects by Patrick Weber

European Federation for Medical Informatics (EFMI) Managing Director, Patrick Weber provides an overview of four European Union funded current projects that are supported by EFMI showing the nature and range of activity being undertaken.



EU funded Project:101016834 Horizon 2020 research & innovation programme. Project from Jan 2021-May 2024.

The HosmartAl vision is a strong, efficient, sustainable and resilient European healthcare system benefiting from the AI capacities of European technology stakeholders to generate impact. The HosmartAl mission is to guarantee the integration of digital and robot technologies in new healthcare environments with the possibility to analyse their benefits by providing an environment where digital healthcare tool providers will be able to design and develop AI solutions as well as a space for the initiation and deployment of AI solutions. Eight different pilots are expected to demonstrate the integration of AI in the health care sector.

OneAquaHealth COVERNANCE-01. Project: 101086521 HORIZON-CL6-2022-GOVERNANCE-01. Project from Jan 2023-Dec 2026.

This project came from the assumption that urban aquatic ecosystems are extremely relevant connectors between people, animals, and plants, making cities more biodiverse and sustainable. The aims are to improve the sustainability and integrity of freshwater ecosystems in urban environments. The project will identify early warning indicators and enhance environmental monitoring with AI-assisted tools by investigating the interconnection of ecosystem health and human wellbeing.



EU funded Project: 1101095448 HORIZON-HLTH-2022-IND-13-01. Project from Jan 2023 - Dec 2025.

The MedSecurance project stands at the forefront of technological advancements aimed at enhancing healthcare services across Europe. With a primary focus on securing medical data and ensuring patient confidentiality, the project seeks to revolutionize the way healthcare institutions manage and safeguard sensitive information especially those which are exchanged between IoMT Devices. At its core, MedSecurance addresses the pressing need for robust cybersecurity measures within the healthcare sector.

INSAFEDARE	

EU funded Project: 101095661 HORIZON-HLTH-2022-TOOL-11-02. Project from Nov 2023 - Oct 2026.

INSAFEDARE aims to provide a toolkit to enable cost-effective and high assurance decision-making in the context of processes that all stakeholders may follow as part of regulation of medical devices. The toolkit consists of scientific guidance on assurance, tools to retrieve datasets and assist application validation and a publicly available guidance work-group for sustainable support of the discipline. INSAFEDARE investigates use, challenges and opportunities for real world and synthetic data-driven validation of devices and will provide guidance on guality and safety assurance of datasets.

Honorary Member - Carole Gassert by Diane Skiba

Carole A. Gassert, PHD, RN, FAAN, FACMI, has now retired from her position as the Associate Dean for Information and Technology and Nursing Informatics Program Director at the University of Utah, in the United States. Carole first entry into informatics was as a cardiac surgical clinical nurse specialist implementing a bedside clinical information system.

In her doctoral program, she was mentored by Dr. Susan Grobe and upon graduation was hired by the University of Maryland to initiate one of the first masters programs in nursing informatics. She was also instrumental in developing their doctoral program in nursing informatics.

Carole later served as the Informatics Nurse Consultant and Advisor for Informatics and Distance Learning in the Division of Nursing, Bureau of Health Professions, Health Resources and Services Administration. In this role she was instrumental in leading a task force to revise the scope of practice and standards for nursing informatics.

Dr. Gassert also served on various national committees, in particular, the American Medical Informatics Association, the American Nurses Association, and Sigma Theta Tau International. In addition, she also served on various IMIA NI planning committees.
