



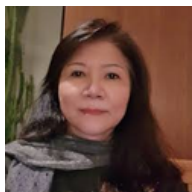

### IMIA NI March 2025 Meeting Summary Date: 28 March 2025

On 28 March 2025, the IMIA NI Executive Committee hosted two global virtual meetings that brought together IMIA NI committee members and society representatives from across the world – including participants from Brazil, Denmark, Finland, Germany, Ireland, Norway, South Africa, South Korea, Sweden, Switzerland, and the USA. These meetings followed two earlier sessions with IMIA NI Honorary Members, during which the Chair, Nick Hardiker, described progress to date for the new Executive Committee and initiated discussions on a refreshed strategic plan for the new term.

### Highlights

Key aspirations and strategic goals of IMIA NI were introduced by Chair Nick Hardiker, followed by vibrant discussions around national nursing informatics (NI) activities and expectations. Here are some of the highlights

- Digital health competencies emerged as a unifying theme across countries.
- Members expressed interest in:
  - Contributing to Advisory Panels.
  - Developing and sharing educational materials and position statements.
  - Clarifying what Nursing Informatics is for a broader audience.
  - Strengthening national structures and local NI networks.
  - Enhancing the visibility and recognition of country representatives.
- A review of the Strategic Plan found the structure strong, however feedback highlighted a need for more concrete, actionable goals and inclusion of mentoring systems and webinars.

### March and April 2025 round up, nursing informatics is experiencing global advancements

#### European Initiatives

Digital Skills Enhancement for Health Professionals: A consortium of 12 European universities launched the Sustainable Healthcare with Digital Health Data Competence (Susa) project, funded with €12.4 million by the EU's Digital Europe programme. This initiative aims to enhance the digital skills of health professionals, including nurses, through various educational programs, addressing the need for advanced digital training in healthcare.



#### Improving Collaboration Through Health Information Systems: Still a Work in Progress

A recent study by Lääveri et al. (2024) explores how health information systems (HISs) have supported collaboration between physicians and registered nurses (RNs) in Finland from 2010 to 2023. While HISs are crucial for enhancing communication and care continuity, the research reveals ongoing limitations in supporting interprofessional collaboration. Both physicians and RNs reported smoother collaboration within their own professional groups than between each other, with RNs generally more satisfied with the systems. Key challenges include hard-to-read nursing documentation, poor visibility of new orders, and insufficient patient summary tools. The study underlines the importance of developing HIS features that better serve the diverse needs of healthcare professionals and support more effective teamwork.

#### AI robots may hold key to nursing Japan's ageing population

AI Robots in Elderly Care: In Japan, AI-driven robots like AIREC are being developed to address the shortage of aged care workers. These robots are designed to perform tasks such as shifting patients, cooking, and folding laundry, aiming to support elderly care amid a rapidly aging population.

#### Professionals Want a Greater Voice in HIS and CIS Development

A recent study published in JMIR Human Factors sheds light on the experiences of Finnish physicians, registered nurses (RNs), and social welfare professionals (SWPs) regarding their involvement in developing health and client information systems. Drawing on national survey data from 2020–2021, the study reveals low participation rates across all groups—76% of physicians, 78% of RNs, and 67% of SWPs had not been involved in system development.

Key insights include physicians being the most critical of vendor collaboration and feedback processes, while leaders were more engaged yet still dissatisfied. Younger professionals expressed the least satisfaction and had minimal involvement. Importantly, professionals given time during work hours for development tasks reported slightly improved perceptions of vendor responsiveness.

The study emphasizes that meaningful engagement—not just time allocation—is essential to ensure systems meet frontline needs. Improved dialogue between system developers and diverse user groups, especially younger and frontline staff, is vital.
